“Our first phase (of vaccination) comprises priority groups with high risk of mortality and our healthcare and frontline workers. For them, we believe, we have enough stockpile,” he told *PTI* in an interview.

“Financial aid of ₹5,000 has been provided to those who returned with a valid passport and job visa since January 1, 2020, and were unable to return due to the lockdown. A project called ‘Dream Kerala’ has been formulated to utilise the skills of returned migrants for the state’s development and employment
